Greetings from the Savannah Senate of TNBA, Inc.

We hope that this finds everyone healthy and doing well.

Attached is a copy of the 21st Annual Mixed Team and Mixed Doubles Tournament application.

We have made the following changes this year as a result of the coronavirus pandemic and the need to social distance:

1. At this time based on the current environment, we are planning to use EVERY OTHER PAIR of lanes (subject to change), which means we will be limited to 24 teams per squad.
2. There will be three squads for the **TEAM** event on **Saturday each weekend** (8:00 am, 11:00 am and 3:00 pm).
3. There will be three squads for **DOUBLES** event on **Sunday each weekend** (8:00 am, 11:00 am and 3:00 pm).
4. The tables/chairs will be socially distanced (as per bowling center requirements) and will be sanitized prior to each squad. There will be sanitizing stations setup throughout the bowling center for your convenience.
5. To facilitate the check-in process, we are requesting coordinators to attach copies of all bowlers USBC and TNBA cards with the entry form. These copies may also be submitted separately via email to: wdgttlw@aol.com at the time the entry is mailed.
6. Brackets will be offered through individual entry forms at a table specifically set up for brackets. This will replace the single sign-up sheet used in the past. This table and area will be sanitized after each shift.
7. As of this mailing, the City of Savannah has in place, an Executive Order requiring a mask be worn in all public facilities.
8. USBC has added "alcohol" back to the list of permitted cleaners for bowling balls. Alcohol is the only ball cleaner approved to be used to clean your ball during the competition. All other approved cleaners may be used **PRIOR to competition or at the COMPLETION of competition ONLY.**

The **tournament application deadline is DECEMBER 9, 2020.** Due to the decrease in the number of applications we will be able to accommodate, we urge anyone wishing to bowl in the tournament to submit their application(s) early.

While we are hopeful we will have returned to some similarity of what we know to be normal by the start of the tournament, we are taking everyone possible precaution to provide you with a safe environment.

TOURNAMENT RULES AND REGULATIONS

Read These Rules and Regulations Carefully – Failure to Read is No EXCUSE

ENTRY DEADLINE: ENTRIES close midnight, Wednesday, DECEMBER 09, 2020

1. THIS TOURNAMENT SHALL BE CERTIFIED

AND OPEN TO ALL TNBA/USBC members, and

will be operated under the tournament rules of TNBA, and USBC. Any entrant who cannot present his/her USBC and/or TNBA membership card prior to bowling will be required to purchase the necessary membership card on site. **No membership application stubs will be accepted.** TNBA membership cards may be purchased at a cost of \$26.00 each. USBC Associate cards may be purchased at a cost of \$25.00 men and women. If said membership cards are shown prior to the end of the tournament that day, full refunds will be made. Anyone entrant not adhering to the above rule, **will not be allowed to bowl in the tournament.**

2. The Tournament will consist of MIXED Teams and MIXED Doubles events. Teams on Saturday and Doubles on Sunday. Optional singles while bowling doubles. Separate singles division for women and men. Men cannot enter the women's singles and the women cannot enter the men's singles. If you are bowling on more than one team, please send all entries in together.

3. **USBC RULE 310a WILL APPLY.** "No late entries will be accepted". The Tournament Directors and/or Committee reserve the right to reject any entry for any reason and return any entry fee. Additional squads may be added to tournament prior to last squad.

4. **PERSONAL/BOWLING CLUB CHECKS WILL NOT BE ACCEPTED.** Fees in the form of MONEY ORDERS, BANK CHECKS or CERTIFIED CHECKS only must accompany application form.

5. **SOCIAL SECURITY NUMBERS will be required for all bowlers who WIN \$300.00 OR MORE, prior to our mailing your check. (NO NICKNAMES PLEASE). INDIVIDUAL ADDRESSES FOR ALL BOWLERS IS REQUIRED.**

6. **Multiple Entries Permitted.** However, you can cash only once with the same partner. Not more than two (2) players on the same team may re-enter; two (2) players must be dropped and two (2) new ones picked up. Teams will consist of (4) players any mixture of men/women combinations **Doubles will consist of (1) one male and (1) one female.** Bowlers can CASH only ONCE with the same partner. Bowlers may PLACE only ONCE in the optional singles event. Any bowler that has held a PBA membership card in the pasts (5) five years will not be allowed to bowl. A bowler may only bowl on one entry (pair of lanes) per squad.

7. Entrants must use their highest **USBC (Bowl.com)** average based on minimum of (42) games for the 2019-2020 season. **NO SUMMER LEAGUE AVERAGES MAY BE USED.** All **SPORT** and **CHALLENGE** averages are to be converted to a Standard Average as per the appropriate USBC Conversion chart before being used in this tournament. All others must use their **HIGHEST CURRENT CERTIFIED AVERAGE** at the time of bowling, based on a minimum of 42 games. A League Standing sheet signed by the League secretary is required. If none of the above, the bowler must enter with a 210 average.

USBC Rule 319a.,2-4 will apply. The 10 Pin rule will apply as of Jan. 1st 2021. USBC Rule 319c., Rule 319 and USBC Rule 319e will apply. Average adjustment will apply. (If an entrant has been re-rated before, they must report their re-rated average, even if the entrant did not accept the adjusted average.)

8. If an entrant submits an average less than his/her true average he/she shall forfeit all prize money.
9. Handicap will be 80% of 210 for both men and women. Handicap will be figured individually for each bowler.
10. Replacements shall be permitted and bowler must bowl in the position of original entrant. All rules and regulations herein will also apply to the replacements.
11. The Tournament Committee reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC. Premature termination of the tournament brought about by war, national emergency or emergency causes relating to or from, fire, natural disaster or any other reason beyond the control of the TNBA Savannah Senate, will require thereby, all prizes to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
12. Team Captain must report to the tournament office at least one hour before time scheduled to bowl and present their **TNBA, USBC cards** for each team member. **All changes are to be made, one hour prior to squad time.**
13. Events will be bowl in the order names are listed on the entry form.
14. Team Captains and/or Coordinators will be notified of day and times assigned to bowl. Tournament management reserves the right to add or delete any squad due to the number of entries. **The Tournament Committee's squad schedule will be final. No lane changes will be permitted.**
15. Errors in scoring must be reported to the Tournament Director's office within 24 hours after the games are bowled.
16. Tardy players will start in frames being bowled, with zero being given for each frame missed. If a team refuses to start because a full line-up is not present, they shall forfeit all games, which they decline to bowl. No blind score shall be permitted and a bowler must bowl with and on the same lanes and at the same time his/her team bowls.
17. After entry has been received, no fees shall be refunded except in an emergency, over which the Tournament Committee has no control.
18. Prize funds will be returned 100% in each event Team, Doubles and Singles. The payout ratio will be at least 1:10 in each event including the optional Singles for Men and Woman.
19. **Any rule not covered here will governed by the rules of USBC.**
